30 Year Corrosion Guarantee Bare Aluminum Roofing & Siding Warranty

Everlast Metals (Everlast), subject to the limitations and conditions stated below, guarantees to the original owner that if the commercial or residential aluminum unpainted roofing and siding manufactured by Everlast, applied to the owner's commercial or residential structure, leak as a result of perforation by rust or corrosion from being exposed to:

- Normal Atmospheric Conditions
- Granular Urea, Ammonium Nitrate, Ammonium Sulfate, Red Granular Potash, White Granular Potash, Soluble Potash, Diammonium Phosphate and Mommonium Phosphate.
- Sodium Chloride

TERMS OF GUARANTEE

(1) Within thirty (30) years after application of products or thirty (30) years and six (6) months from date of sale by Everlast, whichever is less - no proration of product cost to owner.

LIMITATIONS

- 1. Everlast does not guarantee against and shall not be liable for any defect in or damage to the product due to any other cause than expressly guaranteed against above, including but not limited to: (a) willful abuse or negligence in, or failure to provide, reasonable maintenance of the products; (b) settlement, distortion, warping, failure or cracking of the panels or structure to which the products are affixed; (c) earthquake, lightning, gale, hurricane, tornado, hailstorm (except for perforations as stated above), wind-borne objects, or other Acts of God, fire, vandalism, riot, insurrection, or civil disorder.
- 2. Everlast SHALL NOT BE LIABLE FOR ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES caused by any defects whatsoever in the products, and owner's EXCLUSIVE REMEDY and damages for any products, including any claim for consequential or incidental damages, shall be limited to repair, or new products sent by Everlast to replace any defective products, at Everlast's option. This writing contains the entire agreement between Everlast and the owner, and THE GUARANTEE CONTAINED IN THE FIRST PARAGRAPH HEREIN IS MADE EXPRESSLY IN LIEU OF AND EXCLUDES ALL OTHER GUARANTEES, EXPRESS OR IMPLIED, INCLUDING GUARANTEES OR WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PURPOSE. Everlast shall have no obligation under this warranty unless Everlast and our Buyer/Supplier have been paid in full for all material.

CONDITIONS

1. For this guarantee to be effective, it must be validated by the owner or by the owner's dealer, contractor or distributor and the owner must present it and proof of purchase of the products and the date of application of products. The owner shall notify Everlast of any defect in his Everlast products within thirty (30) days following its discovery. Notice shall be given by letter mailed to Everlast, 10 Enterprise Court, Lebanon, PA 17042; Attention: Warranty Claims. The owner shall give Everlast the opportunity to inspect the alleged defect before any permanent repair or replacement is begun by anyone and shall return a sample of the defective product to a destination designated by EVERLAST at the owner's expense, if Everlast requests such return. EVERLAST's obligations under this guarantee may be performed at EVERLAST's direction by a dealer, contractor or distributor appointed by EVERLAST for the purpose. EVERLAST reserves the right to discontinue or make changes in any of their products. This guarantee is not assignable or transferable.

EXCLUSIVE REMEDY:

1. If any of Seller's products fail to perform as warranted, the company will, at its option, repaint or replace the defective panels or refund the buyer the price paid for the material. Everlast's total liability is expressly limited to the purchase price of the defective material. Except as provided herein Everlast Metals shall not be liable for any losses, damage or expense, whether direct, incidental or coincidental, caused by or resulting from the use of defective or non-conforming products.
